Sanjiv,

Spoke with Paul Hennigan at Point Park. They did have (tense is important) an arrangement with the Pittsburgh (Carnegie) Public Library. They terminated it for two reasons: 1) the Operating Agreement was not negotiated very well & the library felt it carried too large a share of the costs and 2) "access" issues – Point Park is located right in the heart of downtown Pittsburgh and they found that "vagrants" and others were attracted to the library to use the Internet (in many cases to surf for porn) and also as a place to "flop". This made the students very uncomfortable. Since public libraries pride themselves on "access" this became a very contentious issue. Lastly, they had two librarians – one from the University and one from the public library – who argued over acquisitions and how to build the collection.

Upon reflection, these can be solved & their experience is an important guidepost – a bit of learning from other people's experience and mistakes.

I would think that same sentiment should also carry over to collaborations between public and private institutions. Since Roger did come over to discuss the possibility, Sari and the Board are obviously open to the possibility of doing something, but whatever is done would have to also meet the Board's other criteria. As you conveyed in your presentation to the NDC Board, we all have to think outside the box and I think the fact both institutions are willing to consider this is already a significant step.

In Chicago, DePaul built a building that houses a branch of the Chicago public library on the first floor and DePaul facilities on the upper floors. It is in downtown Chicago. The library prepaid a 30 year lease; DePaul and the library did not merge collections. I am playing phone tag with Paul Hennigan, President of Point Park University trying to confirm that Point Park and the Pittsburgh Public Library share a facility. I have been told this by numerous people, but I want to verify it and learn what issues they had to resolve.

It's a great concept; the site analysis can be revisited to see if it can work. If the engineer says no, then it was a nice try. We should vett this idea thoroughly because it has the potential for a major win-win-win for the Library, the College and South Euclid.
